Since then they have introduced the Private Tenancies Act (Northern Ireland) 2022 which contains the first phase of PRS reform. Sections 1-6 have already commenced (1 April 2022) and work is progressing on the other parts of the Act. The team are now beginning to look at Phase 2 of PRS reform and Julie and Karen hope to use their breakout session as their first engagement exercise to consider what priorities need to be included in Phase 2.
